

1 Autoilija Application - Terms of Use

The Autoilija application is provided by the Finnish Transport and Communications Agency Traficom, PO Box 320, FI-00101 Helsinki, Finland.

These terms of use apply to the Autoilija application and its data content. By using the Autoilija application, the User accepts and agrees to be bound by these terms of use and other instructions provided in the Autoilija application. By accepting these terms of use and using the Autoilija application, the User gives his or her consent to the processing of personal data on the application. The User can withdraw the consent by deleting the application on his or her mobile device.

1.1 Purpose of the terms of use

The purpose of these terms of use is to regulate the tasks, rights and obligations of the provider and the Users of the Autoilija application. The data content of the Autoilija application consists of these terms of use and the services included in the application, as well as the data in the Transport Register maintained by Traficom.

1.2 Purpose of the application

The Autoilija application is intended for persons that want to be able to present the data included in their personal driving licence in digital format. The service also contains data related to road traffic stored in the Transport Register maintained by Traficom.

1.3 Users of the application

The Autoilija application can be used by any natural person with a Finnish personal identity code and valid strong electronic identification means (online banking codes or mobile ID), as well as a valid right to drive or a previous customer relationship with Traficom. The functionalities available to the User in the application depend on the User's data in Traficom's registers. Limited use of the application, which does not require identification, is also possible. In such case, only the functionality allowing the QR code scan is available. Personal services available in the Autoilija application, such as the mobile driving licence, must always be used with the User's own name and personal data, as well as with the User's own identifiers. The Autoilija application is intended for the User's personal use only. The Autoilija application can also be used by an owner or a holder of a vehicle.

1.4 Logging in to the application

Users log in to the services of the Autoilija application using strong electronic identification. The application data is protected by a four-digit access code selected by the User in connection with the registration. After initial registration, the User may also use a biometric identifier if the User's mobile device allows, for example, using a fingerprint as an identifier.

1.5 Processing of personal data and privacy protection

The data displayed to the User in the Autoilija application is administered in the Transport Register maintained by Traficom and in background systems.

The personal data in the Transport Register maintained by Traficom is processed in connection with the use of the Autoilija application. When the User starts using the Autoilija application by logging in to the service, the mobile driving licence included in the application features a facial photograph already entered in Traficom's system or used in the User's passport or personal identity card. The photograph shall not be more than five years old. By logging in to the Autoilija application, the User gives his or her consent for using the above-mentioned data in the mobile driving licence. All personal data is processed in compliance with legislation on the processing of personal data. Personal data and the facial photograph are saved in the User's mobile device in an encrypted format, which enables using the Autoilija application offline. This means that the User can also use the Autoilija application without a network connection. The User can delete the data saved in the Autoilija application in the settings of the application. Other data displayed in the application is saved, appropriately protected, on the User's mobile device, to the extent required by offline use. The data will be erased from the mobile device when the User deletes the application or logs in to the application again, however, no later than within six months of storing the data. Ensuring the proper functioning of the Autoilija application, analysing the use of the application and processing customer feedback sent via the application involves the processing of data on the User's mobile device based on the User's consent, which the User gives by accepting these terms of use. 1.6 Analysis services

In order to improve the technical functioning of the application, the application uses analysis services provided by third parties, provided that the User explicitly consents to such use. The analysis services provided by third parties, which require the User's consent, are Firebase and Crashlytics.

The purpose of Firebase is to examine and optimise customer behaviour in applications. In this connection, anonymised user data will be forwarded to Firebase. Anonymisation means the processing of personal data so that the person in question can no longer be identified based on the data. Other Firebase functions are also used in the application, allowing better guidance for application users, the analysing of sources of errors and the use of push notifications. Firebase is Google's subsidiary and its head office is located in San Francisco (CA), USA. Firebase's privacy policy is available at <https://www.firebase.com/terms/privacy-policy.html>.

The application also uses the Crashlytics service provided by a US company Crashlytics Inc. Crashlytics is part of the Google group. Crashlytics identifies software errors and their causes. For this purpose, it collects data, including device condition, terminal device type and device ID. The data is stored in a pseudonymised form. Pseudonymisation means the processing of personal data so that the data can no longer be connected with a specific person without the use of additional data. 1.7 Consent to disclose personal data based on a QR code

When using the application, the User may create a unique and temporary QR code. The QR code can only be used once and is valid for no more than five minutes. By giving the QR code, the User also agrees that the QR code recipient may retrieve the User's personal data stored in the Transport Register via Traficom's interface. The User's photograph is displayed to the recipient if the recipient has logged in to the application. Otherwise, a unique identification code is displayed instead of the User's photograph. Traficom stores the data created in the retrieval of the personal data.

1.8 User's obligations

The User is responsible for the technical functioning and information security of the devices, software and data communications connections for using the Autoilija application. In order to ensure proper functioning of the Autoilija application, the User must see to always having the latest version of the application.

The User may only use the Autoilija application for the purposes specified in the terms of use. The right to use the application is personal and it may not be transferred to other parties. The Autoilija application may contain components of third parties. All intellectual property rights and other rights related to the Autoilija application belong to Traficom, its partners and licensors, except for the open source software components.

The User is responsible for ensuring that he or she does not use the Autoilija application in a manner violating the law or other official regulations. Falsifying official documents is punishable by law. The User may not copy or edit the application or decrypt it into the source code, create derivative versions of it, or otherwise attempt to access the source code of the Autoilija application. Furthermore, the User may not attempt to disable or circumvent any protection mechanisms used in the Autoilija application.

If the User's means of identification or payment are disclosed to third parties or lost, the User must immediately notify this to the organisations that have provided these means of identification or payment. If the User fails to notify the organisations in question, the User is responsible for any damage arising from the misuse of the Autoilija application in the User's name.

1.9 Service provider's obligations

Traficom is responsible for ensuring that the protection and encryption methods used in the data transfer and processing related to Autoilija application are appropriate and provide the level of data protection and information security required by law when the application is used.

Traficom does not guarantee continuous availability of the application. The driving licence part of the Autoilija application does not replace a physical driving licence and Traficom is not responsible for the suitability of the Autoilija application for proving age or identity. Traficom makes every effort to ensure continuous availability of the Autoilija application and that the data displayed in the Autoilija application is as up-to-date and accurate as possible. However, Traficom does not

guarantee that the application is available without interruptions. Traficom also has the right to suspend the use of the application if necessary, for example, due to installation, modification or maintenance work, or if required by law or other legal provisions, or if there are other acceptable reasons for such a suspension. Traficom will make every effort to ensure that the suspension is as short as possible. Traficom will make every effort to give reasonable prior notification of outages and suspensions in the use of the application. Traficom is not responsible for any service interruptions arising from the identification service provider or a device connected with it. Traficom also has the right to terminate the provision of the service without a separate notification.

Traficom has the right to develop the Autoilija application and provide it in the manner that it considers optimal. The User is responsible for any changes in his or her terminal device required by these changes and for any costs arising from the changes. Traficom will make every effort to give reasonable prior notification of all changes having a major impact on the use of the Autoilija application.

Traficom is not responsible for any direct or indirect damage, loss or costs arising from the Autoilija application or its use.

1.10 Other terms

Traficom has the right to change these terms of use by updating them in the Autoilija application. The changes take effect once the User has accepted the term of use. The terms of use are also available on the Autoilija website.
