Grounds for and purpose of data processing

Traficom and the Finnish Transport Infrastructure Agency have acquired consulting work together with the objective of creating a proposal of how C-ITS services should be implemented in Finland and what the roles of the authorities, in particular, in the implementation of the services and the required infrastructure as well as in monitoring C-ITS services and C-ITS units should be. As part of the work, a consultant will be interviewing the clients' experts and external experts.

According to section 2, subsection 1, paragraph 6 of the Act on the Finnish Transport and Communications Agency, the Finnish Transport and Communications Agency promotes digitalisation and automation in transport and communications and their markets and enables pilots, research and innovations concerning transport and communications.

According to section 2, subsection 1, paragraph 1 of the Act on the Finnish Transport Infrastructure Agency, the Finnish Transport Infrastructure Agency is in charge of the state road network it manages and its development as well as the harmonisation of the related operations throughout the country. It also promotes the digitalisation and automation of transport services and the transport system according to paragraph 4. According to section 3, subsection 1, paragraph 5; section 4, subsection 1; section 10 and section 11 of the Act on the Transport System and Highways, the Finnish Transport Infrastructure Agency is the road infrastructure manager responsible for the highway network. According to section 136, subsection 1 of the Act on Transport Services, the Finnish Transport Infrastructure Agency is, in the capacity of road infrastructure manager, responsible for organising traffic control and management services for the road network under its management as required by the transport services operated on the road network and ensure the quality and fairness of traffic control and management services.

The processing of personal data related to the interviews is based on Article 6(1)(e) of the General Data Protection Regulation and section 4, subsection 1, paragraph 2 of the Data Protection Act, which specifies the aforementioned, according to which the processing of personal data is lawful when it is proportionate and necessary for the performance of a task carried out in the public interest.

The data undergoing processing	The personal data processed in the consulting work are the personal data of the members of the steering group and external experts. The personal data processed in the work are the names, email addresses, telephone numbers and titles of experts.



Right of access	The data subject has the right to obtain from the controller confirmation as

Right to rectification	The data subject has the right to obtain from the controller without undue delay the rectification of inaccurate or incorrect personal data.
Right to object	In situations where the processing of personal data is based on public interest, the exercise of official authority vested in the controller or the legitimate interest of the controller or a third party, the data subject has the right to object to the processing of personal data concerning him or her. If a data subject uses his or her right to object, the controller must stop the processing of the personal data, unless the controller demonstrates
	compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject, or for the establishment, exercise or defence of legal claims.
Right to restriction of processing	The data subject has the right to obtain from the controller restriction of processing if: - the data subject contests the accuracy of the personal data - the processing is unlawful, but the data subject opposes the erasure of the personal data and requests the restriction of its use instead - the controller no longer needs the personal data for the purposes of the processing, but it is required by the data subject for the establishment, exercise or defence of legal claims - the data subject has objected to the processing of the personal data pending the verification of whether the legitimate grounds of the controller override those of the data subject.
Right to data portability	The data subject has the right to receive the personal data concerning him or her, which he or she has provided to the controller, in a structured, commonly used and machine-readable format and the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided, where the processing is based on consent or on a contract and the processing is carried out by automated means.
Right to erasure	In situations where the legal basis for the processing of personal data is something other than compliance with a legal obligation, the data subject has the right to obtain from the controller the erasure of personal data concerning him or her. The requested data will be erased unless the controller has a legal basis for refusing to erase the data, such as a legal obligation to retain the data.
