If, however, the information provision requires that the work is sub-contracted to suppliers outside Transport and Communication Agency due to a large volume of data or for some other technical reason, the additional expenses incurred by Transport and Communication Agency for such work will be charged.

Fees according to this section will be charged from persons and entities other than government offices and agencies.

No fees are charged from Transport and Communication Agency's partner companies for application queries made for the performance of assigned regulatory duties.

3.2 Direct marketing services

Fixed charges

The analysis services must be associated directly with address sales, and the focus must be on refining the Transport and Communication Agency's database in such a manner that the target is a car buyer.
