## Grounds for and purpose of data processing

The processing of data is based on the consent of the person using the Autoilija application. The Autoilija application processes data on the user's mobile device to ensure the proper functioning of the Autoilija application, to analyse the use of the application and to process feedback sent via the application. The data in the Transport Register displayed in the Autoilija application is described in a separate privacy policy, available at <a href="https://www.traficom.fi/en">www.traficom.fi/en</a>.

Users can withdraw their consent by deleting the Autoilija application on their mobile device.

<b>Data content</b>	
Data in the register	Name and operating system version of the user's mobile device; PIN code created by the user in connection with strong identification, which the user uses to log in to the application after initial identification; timestamps describing the use of the Autoilija application; administrative number specifying the identification; as well as feedback sent by a user via the application and a customer ID specifying the feedback. Data content transmitted in the data verification by QR code (age 18+/20+, personal data, driving right) is saved temporarily in the database in an encrypted format. The data will be erased upon scanning or expiry of the QR code.
Data sources of the register (Where is the data obtained from?)	The data is obtained from the mobile device of a logged in user.
Storage period of personal data	6 months. The data is stored on Traficom's servers located in Finland.

Rights of data subjects				
Right to access own data	The data stored on the use of the application is either defined by the user (PIN code) or created by the user. If necessary, some of the data can be accessed by contacting <a href="mailto:kirjaamo@traficom.fi">kirjaamo@traficom.fi</a> . The PIN code cannot be provided due to information security reasons.			
Right to rectification	The data stored on the use of the application is either defined by the user (PIN code) or created by the user, which means that the right to rectification by the controller does not apply.			
Right to object	Users can delete the application from their mobile device if they do not want their personal data to be processed for ensuring the proper functioning of the Autoilija application and analysing the use.			
Right to lodge a complaint with a supervisory authority	The data subject has the right to bring the matter to the data protection officer if the data subject considers that the processing of their personal data infringes applicable legislation.  This right is without prejudice to any other administrative or judicial remedy.			
Right to data portability	The data stored on the use of the application is either defined by the user (PIN code) or created by the user. If necessary, some of the data can be accessed by contacting <a href="mailto:kirjaamo@traficom.fi">kirjaamo@traficom.fi</a> . The PIN code cannot be provided due to information security reasons.			
Right to erasure	Users can erase the data saved on their mobile device in the settings of the Autoilija application. Moreover, the data will expire in six months after which it will be deleted automatically.
