Sources of the pro- cessed data (where data is received from)	The data source is the registration form hosted on the Webropol plat- form.
Storage period of personal data	Webropol stores data collected through cookies for 14 days. Registration data are stored on Webropol Oy's service platform for 90 days from the end of the registration period, after which they are transferred to Traficom's own server and anonymised within six months of the workshop. Survey data deleted from the Webropol service are stored by Webro- pol on servers for one year after deletion, after which they are de- stroyed.

Recipients and cate- gories of recipients of personal data (to whom personal data is disclosed)	Personal data are stored on Webropol Oy's service platform.
Processing of per- sonal data on behalf of the controller	Webropol Oy (business ID: FI17739602) serves as the processor of the personal data and its subcontractors Telia Inmics-Nebula Oy (busi- ness ID: 2546028- 1) and Qumio Oy (business ID: 2466203-3) serve as sub-processors.
Transfer of personal data to third coun- tries outside the EU/EEA	Personal data are not transferred outside the EU/EEA.
Automated decision- making and profiling	The personal data processing does not involve automated decision- making or profiling.

Right of access	The data subject has the right to obtain from the controller confirma- tion as to whether or not personal data concerning him or her is being processed. If processing takes place, the data subject has the right to access the personal data.
Right to rectifica- tion	The data subject has the right to obtain from the controller without undue delay the rectification of inaccurate or incorrect personal data.
Right to object	In situations where the processing of personal data is based on public interest, the exercise of official authority vested in the controller or the legitimate interest of the controller or a third party, the data sub- ject has the right to object to the processing of personal data con- cerning him or her.
	If a data subject uses his or her right to object, the controller must stop the processing of their personal data, unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject, or for the establishment, exercise or defence of legal claims.
	If the personal data is processed for direct marketing purposes, the data subject has the right to object to the processing without any specific grounds.
	In situations where personal data is processed for statistical or re- search purposes, the data subject may object to the processing on grounds relating to his or her particular situation, in response to which the controller must stop processing the data subject's data, unless the processing is necessary for performing a task carried out for reasons of public interest.
Right to restriction of processing	<ul> <li>The data subject has the right to obtain from the controller restriction of processing if: <ul> <li>the data subject contests the accuracy of the personal data</li> <li>the processing is unlawful, but the data subject opposes the erasure of the personal data and requests the restriction of its use instead</li> <li>the controller no longer needs the personal data for the purposes of the processing, but it is required by the data subject for the establishment, exercise or defence of legal claims</li> <li>the data subject has objected to the processing of the personal data pending the verification of whether the legitimate grounds of the controller override those of the data subject.</li> </ul> </li> </ul>
Right to data porta- bility	The data subject has the right to receive the personal data concerning him or her which he or she has provided to the controller in a struc- tured, commonly used and machine-readable format and the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided, where the processing is based on consent or on a contract and the processing is carried out by automated means.
Right to erasure	In situations where the legal basis for the processing of personal data is something other than compliance with a legal obligation, the data subject has the right to obtain from the controller the erasure of per- sonal data concerning him or her. The requested data will be erased unless the controller has a legal basis for refusing to erase the data, such as a legal obligation to retain the data.

Right to withdraw consent	Insofar as personal data is processed on the basis of the consent of the data subject, the data subject may withdraw his or her consent at any time by notifying the controller of the withdrawal. Withdrawing consent will not affect the lawfulness of processing carried out on the basis of the consent of the data subject before its withdrawal.
